







**20-Year Average Annual Total Return**


August 1999 - August 2020


**Adjusted 20-Year Average Annual Total Return**

August 1999 - August 2020





1972 - 2019








FTSE Nareit All Equity REITs:

## Dividends Paid by All Listed U.S. Equity and Mortgage REITs


